# The Market at The Ice House Rules and Regulations

**Mission of the market:** Our mission is to improve and provide a variety of local goods to the Greater Lake Region area. We strive to encourage the motto "Shop Local" to promote growth within our community through local farmers and artisans.

#### Rules the market will live by

- **A.** Membership is open to producers in the surrounding region. A selection committee with the best interest of the market in mind votes membership on. The market believes that competition produces the best products. All applications will be considered, however, vendor selection may be based on how many of a given type of vendors is already approved at the market.
- **B.** Only food products may be brokered and then only 20 % of a vendor's selection may be brokered at any given time. Brokered items are limited to area fruits and vegetables, local farm raised meats, and products like pickles. These items may only be brokered if no other vendor/grower is producing these items. The selection committee must approve brokered items.
- C. The selection committee/manager/market contact, reserves the right to inspect farms, both announced and unannounced, to verify that products sold at the market are actually produced by members and in enough quantity to support the sale of those products.
- **D.** All necessary certificates and permits required by a vendor must be in place at the time of the market. All health department rules and regulations are to be followed. It is the responsibility of the member to know what is necessary. Failure to comply can bring about dismissal from the market and a loss of membership
- **E.** Weekly stall fees are \$25 per stall and must be paid weekly. Vendors may pay for the entire season –at time of application- if they are so inclined.
- **<u>F.</u>** Rudeness is to be avoided. Rudeness to other vendors, customers and market manager or contact could result in membership cancellation.
  - **G.** The market manager or contact is responsible for the orderly running of the market. Vendors will comply with the manager/contacts wishes regarding the operation of the market such as: placement, signage, tardiness etc.
- **H.** Tardiness is not allowed at the market. Vendors will show up a minimum of ½ hour before market opens and be ready to sell at the time of market opening. Vendors maybe sent home it they are consistently late and will not be allowed in the market unless they arrive in a timely fashion.

#### Market Guidelines for Selling at The Market at The Ice House

- **A.** A *professional* sign announcing the business name and location is strongly suggested along with highly visible prices. A barn wood sign can be made for you upon request for a \$40 fee.
- **B.** Members are required to provide their own tables, chairs, signage, displays and tents. EZ-up tents are suggested for outdoor spaces. Tent weights are a must. Unweighted and untied-down tents may subject the vendor to fines of \$10 per incident after the first verbal warning.
  - C. Pre opening sales are frowned on and are discouraged unless otherwise approved by the market manager/contact
- **D.** Members are responsible for their area; please clean up any garbage or debris generated by selling at the market. Have garbage receptacle readily available to customers.
  - E. No loud music will be allowed.
  - **F.** No discrimination is allowed.
  - **G.** A product knowledgeable representative should attend the market if the Member cannot.
- **<u>H.</u>** Violation of the rules will be addressed with a verbal warning. After the verbal warning has been given a member may be dismissed from the market and membership in the The Market may be withdrawn.
